## HOW TO MAKE A RESERVATION

1. Pick several dates from the trip schedule and call the office at 800-786-7238 or email info@azraft.com to check availability and reserve your spot(s).
2. If trip date is not available, place your name on a waitlist (no charge) because there are frequent cancellations.
3. To secure reservation, make payment of non-refundable 15% deposit per person to our office within 10 days of making a reservation.

### **CANCELLATION / REFUND POLICY**

All payments are refundable until 120 days prior to your trip date (180 days for charters), less the 15% per person deposit, which is non-refundable. NO refunds are available after the 120 day deadline. We strongly recommend you purchase trip cancellation insurance (www.travelex-insurance.com). All cancellations in writing please.

### **\$1/DAY CONTRIBUTION HELPS PROTECT THE GRAND CANYON**

A one dollar per day contribution is "passed through" from your fare directly to conservation groups and other environmental organizations working to protect the Grand Canyon. ## TRIP TYPES

### **Classic Adventure**

A non-motorized option consisting of 4, 18' oar rafts, 1 hard-sided dory boat and one 18' paddle raft. Offers a partial paddle experience. Great for groups of mixed abilities and interests.

### **All Paddle Adventure**

A non-motorized rafting option offering 100% paddle boat participation.

### **Motor Adventure**

34 foot raft propelled by a motor.

## SPECIALTY TRIPS

### **Hiker's Discovery**

Designed for hiking enthusiasts. Slightly longer trip lengths allows for ample time to explore many side canyons as you raft down the river, some of which we may visit only once or twice all season.

### **Kayak Support**

Team up with one of our preferred kayak schools for a trip designed to kayak the Grand Canyon.
